NOW THEREFORE, in consideration of the mutual promises and subject to the terms and conditions contained herein the Higher Education Department (hereinafter) HED, Government of Odisha and the IIT Bombay-Spoken Tutorial Project (collectively referred to as "the Parties")

IIT Bombay- Spoken Tutorial Project (Implementing agency) having its Principal office at IIT Bombay through Mrs Shyamalyer, National Coordinator-Training, Spoken Tutorial (ST) Project-IIT Bombay, Powai, Mumbai-400 076 agree as follows:

NOW, THEREFORE, the Parties agree as follows:

1. As the project IIT Bombay -Spoken Tutorial (ST), Govt. of India provides easy to learn Audio-Video tutorials for students to learn actively, on their own, the Basic computer skills, Multimedia and other job oriented IT skills and till date 47 lakh college students covering all States and 75% districts in India have been trained using this method, it is decided that students as well as faculties in the colleges of Odisha under Higher Education Department will be trained in similar manner.
2. It is an audio-video method to learn Software, developed by IIT Bombay. These are for Skills and to improve Academic performance of the students as well as faculties. It is designed for self-learning (no expert needed) and distance education mode (no need to leave campus).

3. Activities of Higher Education Department, Odisha: HED, Odisha shall:-

- 3.1 Make the payment of consolidated User Fee to IIT Bombay-ST, for 100 selected colleges (**Annexure-A**) at the rate of Rs 25,000/- (Rupees Twenty five thousand) only per College per year.
- 3.2 Nominate Officer-In-Charge, State Performance Tracking Cell (SPTC) to act as Central Co-ordinator, who will interact with IIT Bombay to send Notifications/ Circulars and for activities related to introduce Spoken Tutorial based Software Training in colleges.
- 3.3 Request Director, College Development Council of each University to monitor the implementation of the said project of the affiliated colleges under its jurisdiction.
- 3.4 Shortlist 100 colleges and share the Principal contact details with IIT Bombay manager.
- 3.5 Arrange Faculty Awareness cum Master Training program for selected 100 colleges in February, 2019.
- 3.6 Send Regular reminders to the identified colleges and quarterly Status updates to be sent to Odisha Training Manager- ST IIT Bombay for a systematic and timely roll out of the Training program in each college.
- 3.7 Upload the Spoken Tutorial program details on the website of HED.

4. Activities of the participating Colleges: Colleges shall:-

- 4.1 Contact the IIT Bombay, Training Co-ordinator to start training and for more information.
- 4.2 Appoint Faculty Co-ordinator and share the contact details with IIT Bombay, Training Co-ordinator, Odisha.
- 4.3 Conduct training on any courses and train any number of students and faculties to get certificates.
- 4.4 Share the plan of the ST training with IIT Bombay, Training Co-ordinator, Odisha.

5. Activities of Implementing Agency (IA): The Implementing Agency shall:

- 5.1 Work as a mentor for Higher Education Department, Odisha.

5.2 Support the Training and roll out by Higher Education Department, Odisha by providing day to day guidance and support at college level.

5.3 Hire or appoint its own personnel for performing the Assignment and will keep the HED informed of the current and updated list of such personnel. Any payments, including consultancy charges and honorarium, to be made the permanent staff, faculty or other personnel engaged in performing the Assignment will be made by the Implementing Agency in accordance with the rules, norms or guidelines applicable to the Implementing Agency.

5.4 Appoint two(02) field officers, who will be stationed in Odisha to guide the colleges to start the training on the software, developed under ST Project (Annexure-B).

5.5 Provide the know-how and course content which includes online material, instruction sheets and other training documents to colleges.

5.6 Provide the promotional materials like posters, brochures, leaflets, banners etc., to colleges.

6. Payment of Terms

6.1 The HED will pay the Implementing Agency an aggregate sum of Rs.25,00,000/-(Rupees Twenty five lakh)only for the Assignment. This amount includes all of the Implementing Agency's costs and deliverables as well as any tax obligations that may be incurred by the Implementing Agency.

6.2 The Schedule of payment will be as follows:

First instalment upon the receipt of an interim report confirming the progress of training program after 06 months of the signing of the project	40%
Second instalment upon the receipt of the final report from Implementing Agency, acceptable to HED	40%
Final instalment only after submission of Statement of Accounts, for the entire duration of the Assignment, audited by Government auditors or by a reputed Chartered Accountant, as applicable to Implementing Agency.	20%
Total	100%

6.3. The payment released by the HED must be used only for meeting the approved expenses of assignment.

6.4. The Implementing Agency shall submit an invoice to the HED each time a payment is due.

6.5. The payment of final instalment shall be subject to the receipt by the HED of an audited statement of accounts for the entire duration of the Assignment, audited by Government auditors or by a reputed Chartered Accountant, as applicable to Implementing Agency and the progress Report.

7. Term

7.1. This agreement will come into effect from the date on which it is signed by both parties. The Implementing Agency shall perform the Assignment within 01 week from the date of signing of agreement. Both parties agree to perform their obligations in good faith and to the best of their ability in order to meet timeline.

7.2 If the Implementing Agency is not able to complete the assignment during the period referred to Clause 7.1 the HED may agree to extend the timeline for successful completion of the assignment, subject to such terms and without any financial liability to the HED as may be decided by the HED in this regard.

8. Dispute Resolution:

8.1. Parties will make good faith attempt to resolve any disputes arising out of this agreement in an amicable manner through discussion.

8.2 Any dispute arising out of the agreement, which cannot be resolved through discussion, shall be placed for a decision before, the Commissioner-cum-Secretary, Higher Education Department, whose decision shall be binding on the Implementing agency.

9. Reporting, Monitoring and Evaluation:

9.1. The Implementing Agency shall ensure that all formats to be used for performing the Assignment, including surveys, questionnaires, training materials and other information, education, communication products, as applicable, are shared with HED before executing related activities.

9.2 The Implementing Agency will submit half yearly progress report to the HED indicating the status of the Assignment and providing details of the work carried out during that quarter.

9.3. The Implementing Agency will maintain accurate and complete records in respect of funds received under this Agreement. The implementing Agency will make available to HED any records or information, oral or written which the HED may reasonably request in respect of funds released by them.
